Selection Process:

There will be up to four individual bursaries per year in the amount of \$1000, each renewable for a maximum of four years. Funds will be paid to the student on receipt of proof of full-time registration at a post-secondary institution.

The post-secondary program can be either academic or vocational training.

To be considered, submissions must be submitted electronically by **April 30, 2024,** to bursary@srbc.ca and include:

- a completed application
- a copy of your academic transcripts. For those re-educating, submit a written plan for your re-education.
- one academic/school reference letter and one personal reference letter. For those reeducating, submit two personal references if a school reference is not available.
- a written statement or video as outlined below.

Bursary recipients will be notified by June 1, 2024. Prior to receiving the funds, the successful candidate must be registered for a full course load (as designated by the institution) in a post-secondary program. The committee may consider exceptions to this requirement for candidates in extraordinary circumstances. Funds are paid directly to the student when a receipt for tuition fees is provided by the student.

A post-secondary institution shall be defined as follows:

- a recognized university
- a college offering transfer courses
- an institution which prepares students for specific trades and vocations, and which is recognized and supported by the government (e.g., BCIT)

Bursaries are classed as earnings and are reportable to the CRA. For this reason, bursary recipients will be required to provide their Social Insurance Number to Sunshine Ridge Church prior to disbursement of funds.
